FLIGHTS & TOURIST CARDS/VISAS: There are multiple daily flights to Havana from the United States with American Airlines offering the most departures via Miami. Other airlines offering flights include: Delta, Southwest, JetBlue, and United. As CCT is a tour operator and not a travel agent, we are unable to assist in booking your flights. However, it is easiest to do so directly through the airline websites. When booking flights, the airline will try to sell you a tourist card/visa through a 3rd party (e.g. Cuba Travel Services.) You do NOT need to purchase this as we will provide it to you with your travel documents and it is included in the package price.

TRAVEL DOCUMENTATION: Approximately two weeks prior to the final payment due date you will receive information regarding the necessary forms for travel, final invoice, and our comprehensive travel tips. Approximately two weeks prior to travel you will receive your travel documents and emergency contact information.

A note from Cuba Cultural Travel: Trips to Cuba require quite a bit of walking on uneven cobblestone streets along with stairs where an elevator is not always available. Participants must be able to walk unassisted. Please keep these physical requirements in mind when making your reservation. Cuba is not adequately able to accommodate physically handicapped persons.
